Per each aircraft type:

Maximum number of seats declared and certified by the aircraft manufacturer in a high-density cabin layout/full economy layout

The Ordinary Handling tariff includes:

- Ground Handling Coordination
- Weight and Balance
- Waste Removal*
- A/C Cabin Cleaning
- Toilet service
- Water Service
- Baggage Loading and Unloading
- Passengers Check-in
- Lost and Found
- Handling of baggage from/to BHS/aircraft.

Surcharges

For flights operating between **09.00 pm** and **7.00 am** local time an **additional 30%** of the handling tariffs will be applied.

Yearly Operation Discounts

Frequency	discount
Daily	- 50%
weekly > 4 su 7	- 45%
weekly > 2 su 7	- 40%
2 weekly	- 35%

Yearly Operations

The above discounts can not be combined with volumetric discount

Services Reduction

Technical flight or ferry flight:

50% discount of the Ordinary handling tariff will be applied

Volumetric Discount

50% discount of the Ordinary tariffs (net of surcharges) will be applied in case all the following conditions are met:

- Yearly operations
- Volume traffic increase in comparison with the previous year
- Total annual movements above 3.500
- Compliance with the slots suggested by AssoClearance

April to October Operations

Discount of the ordinary tariffs (net of surcharges)

more than **700** total movements with minimum **25** movements/month

Discount
- **20%**

more than **300** total movements with minimum **16** movements/month

- **15%**

more than **200** total movements with minimum **16** movements/month

- **10%**

The above discounts can not be combined with the yearly operation discount

An Average forfait tariff can be granted upon request to all carriers eligible for the volumetric and yearly operation discount. The forfait tariff will be calculated as the average of all applicable tariffs, weighted by yearly movements operated per aircraft type. Within the 1st December, the carrier shall communicate to the airport management company all the flights schedule, detailing the percentage of aircraft type usage. In case of significant discrepancies between the planned and the effective percentage of the aircraft type usage, the tariff will be accordingly adjusted.

Flight Cancellation and Delay

Flight Cancellation:

Free of charge, provided that the Handling company is notified at least **12 hour before** the flight arrival/departure planned time:
50% of the relevant handling tariff shall apply if aforesaid notification **terms are not met**.

A/C Return to Ramp:

Handling in case of return to ramp will not be extra charged provided that physical movement of loads is not involved. An **additional 50%** of relevant Ordinary Handling Tariff shall be applied if a physical movement of loads occurs. The provision of equipment (GPU, Steps, etc.), eventually requested, shall be charged at the updated Extra-Handling tariff.

Delays:

In case of delay involving a new movement of load, once Handling services have already been performed the following surcharge shall be applied:

- **Up to 4 hours** delay: an additional **50%** of the relevant Ordinary Handling Tariff shall be applied
- **Over 4 hours** delay: an additional **100%** of the relevant Ordinary Handling Tariff shall be applied

Cargo Service:

Tariff per Tons per turnaround **11,50 €**

Any other service not included in the Ordinary Handling Tariff, will be subject to the Extra-Handling services as per updated Tariff.
